**MS 116P.09 Subd 6 Conflict of interest.** A commission member, technical advisory committee member, a peer review panelist, or an employee of the commission may not participate in or vote on a decision of the commission, technical advisory committee, or peer review panel relating to an organization in which the member, panelist, or employee has either a direct or indirect personal financial interest. While serving on the commission, technical advisory committee, or peer review panel, or being an employee of the commission, a person shall avoid any potential conflict of interest.

Susan Thornton explained the conflict of interest in M.S. 116P.09.

MOTION: Commissioner Dahms moved a unanimous ballot for the nomination of Commissioner Ingebrigtsen for the co-Chair for the Senate members – motion prevailed from the Senate members (unanimously).

MOTION: Commissioner Hoppe moved a unanimous ballot for the nomination of Commissioner Heintzeman for the Co-Chair for the House members – motion prevailed from the House members (unanimously).

MOTION: Commissioner Moody moved a unanimous ballot for the nomination of Commissioner Broberg for the Co-Chair for the Non-legislative members – motion prevailed from the Non-legislative members (unanimously).

#### - 3 Co- Vice Chairs (House/Senate/Non-legislative)

MOTION: Commissioner Dahms moved a unanimous ballot for the nomination of Commissioner Tomassoni for the Vice Co-Chair for the Senate members – motion prevailed from the Senate members (unanimously).

MOTION: Commissioner Ecklund moved a unanimous ballot for the nomination of Commissioner Wagenius for the Vice Co-Chair for the House members – motion prevailed from the House members (unanimously).

MOTION: Commissioner Moody moved a unanimous ballot for the nomination of Commissioner Gibson for the Vice Co-Chair for the Non-legislative members – motion prevailed from the Non-legislative members (unanimously).

### 6. Update on LCCMR Appropriations Bill for the 2017 MN Legislative Session Funding Recommendations from the Environment and Natural Resources Trust Fund (ENRTF) – S.F. 550 / H.F. xxx

#### - Additional extensions requested for past appropriations

S.F. 550 is authored by Sen. Westrom and Rep. Heintzeman announced that he will be the author of the LCCMR Appropriations bill and it will be introduced on Wednesday, February 15, 2017.

Susan Thornton provided an overview of the materials in the meeting packets. Ms. Thornton discussed the additional extensions and the LCC Website funding options. Members discussed the LCC Website options. Members agreed they would prefer to have the LCC website dollars included in the LCCMR Recommended Appropriations Bill instead of in separate legislation with the Legacy funds.

Greg Hubinger, LCC Director, provided an overview of the Minnesota Legacy website.

MOTION: Commissioner Broberg moved to recommend adding the additional extensions and the LCC website funding for \$4,500 into the LCCMR Recommended Appropriations Bill as an author amendment – motion prevailed.
