**Summary of Reciprocity Agreements for Metropolitan Regional Park Agencies**

Anoka County	Annual pass is valid for entry into Washington County Regional Parks and it allows holder to purchase a Three Rivers Park District permit at a 40% discount.
Carver County	Annual pass is valid for entry into Washington County Regional Parks and it allows holder to purchase a Three Rivers Park District permit at a 40% discount. In 2004, Carver and Anoka counties will honor
Washington County	Annual pass is valid for Anoka and Carver county regional parks and allows holder to purchase a Three Rivers Park District permit at a 40% discount.
Three Rivers Park District	Annual permit holder may purchase a Anoka, Carver or Washington county annual permit at a discounted rate. Daily parking permits and bus permits are not reciprocal.
Bloomington and Three Rivers Park District	Bloomington and Three Rivers Park District work jointly on parking patrol and associated costs. Three Rivers Park District permit holders can park in Bloomington's Bush Lake Beach parking lot. In return, the Three Rivers Park District ranger patrols the parking area for violators. Proceeds from the parking help pay patrolling costs. If the proceeds are less than \$17,080, the Bloomington owes Three Rivers the difference. If proceeds are greater than \$17,080, then Bloomington keeps the difference.
